Introduction to Virtual Accounts

FV Bank allows customers to generate unique virtual account numbers tied to their beneficiaries. This enables clients to automate the payment attribution with virtual account numbers.

Key

Highlights:

- Pre-generate virtual account numbers for each of your beneficiaries.
- Basic KYC is shared, allowing pre-approval for more streamline transaction approval.
- Provide each counterparty a dedicated virtual account number and deposit instructions.
- 1-to-1 matching of transactions via the unique deposit instructions, whenever a counterparty sends a deposit, for automated reconciliation.

This is an add-on feature with additional costs. The following steps in this user guide will only appear on your banking portal once it has been enabled for your account.
